

St. Paul's United Church hosted the indigenous people event Oct. 17

Monday, Oct. 17, St. Paul's United Church of Christ (201 Buffalo St., Delano) hosted an educational Indigenous Peoples' event with two speakers, one from the Native American Boarding School Healing Coalition, and a woman who works with the Bureau on Indian Affairs in Minneapolis.

They talked about the little-known history of Native American boarding schools. More than 30 people attended to learn about this secret abuse of children.

Last year in a proclamation, President Biden said we should "honor Native Americans, their resilience, and their contributions to American society throughout history, even as they faced assimilation, discrimination, and genocide spanning generations."

This past July, Pope Francis was in Canada, on what he called a "Pilgrimage of Penance." He traveled around to apologize for the Catholic Church's role in residential school systems where Indigenous children were mandated to attend. Residential schools were funded by the U.S. and Canadian governments but administered primarily by the

Catholic Church along with local government agencies and other church denominations.

The mandate was to erase the culture and language of Indigenous children and make them Christians. After being stolen from their families as young children, they were forbidden to speak their native languages, their hair was cut, and they were given new names.

The schools' goal was to assimilate the children and rid them of their cultural ties to their families. The plan was to keep them from ever returning to their parents.

The apology from Pope Francis came after years of allegations detailing abuse and neglect at these residential boarding schools that resulted in the deaths of over 150,000 Native children. Methods of discipline at Minnesota boarding schools were harsh. Some schools had cells or dungeons

where students were confined for days and given only bread and water. Minnesota boarding schools recorded epidemics of measles, influenza, blood poisoning, diphtheria, typhoid, scarlet fever, tuberculosis, pneumonia, trachoma, and mumps, which swept through overcrowded dormitories. Students also died from accidents such as drowning and falls.

The policies implemented led to the deaths of thousands of students through disease, hunger, and malnutrition, and have left a legacy of intergenerational trauma. Today families are combing the vast cemeteries belonging to over 400 boarding schools, looking for their relatives who died while in these schools.

Ten members of the Native American Boarding School Healing Coalition are leading the way to assist families in resolving the trauma caused by the boarding school mandates.
