

Minutes of January 21, 2024 Council Meeting St. Paul's United Church of Christ, Delano

St. Paul's United Church of Christ's Council met January 21, 2024 at 10:55 a.m. Attendees were Council Members Michael Hagerty, James Holm, Judy Crosby and David Rieder, Pastor Bridget Haefner and church members Gretchen Stewart and Vicki Hagerty. Following an opening prayer led by Mike, the Council addressed the following items:

Minutes 12/10/23 Council Meeting. On motion by Jim, seconded by David, the Council unanimously approved the Minutes of the December 10, 2023 with the following edits: (1) change meeting date to "December 10, 2023," and (2) insert in the Minutes "[T]he Council unanimously approved inserting in St. Paul's Five-year Plan "St. Paul's 150th Anniversary Celebration."

<u>Open Forum</u> - Gretchen stated she is available to play piano or organ on dates previously provided; inquired who is responsible for song selection; and advised City of Delano is seeking suggestions on how to provide affordable housing for lower-income residents.

<u>Financials</u>. Jim reported the operating account balance is \$12,800; donations in the past month totaled \$14,700; the Green Wealth account balance is \$399,217. On motion made by David, seconded by Judy, the financial reported by Jim were unanimously approved by the Council. A special meeting of the Council will meet Sunday, January 28, at 10:40 a.m. to focus on the 2024 Budget drafted by Jim and prepare for the Annual Meeting scheduled on February 22, 2024.

<u>Cemetery Committee.</u> Judy inquired re end-of-year financials include a specific designated amount for the cemetery fund. Jim and Mike advised funds for all church needs are in the same accounts, not separated. Should the church be dissolved, a portion of the then available funds will then be moved to cemetery fund. Judy will prepare the Cemetery Committee Report for the annual meeting.

<u>Pastor's Report.</u> Pastor Bridget submitted a letter announcing her retirement effective April 1, 2024. A copy will be published in the church newsletter. Pastor Bridget's resignation was met with disappointment as her presence and service will be profoundly missed. Pastor Bridget stated UCC's Minnesota Council will assist locating pastoral candidates; they also can provide information regarding perpetual cemetery funding. Mike will contact UCC's MN Council.

Handicap Bathroom Accessibility Project. Dave presented a redesign for the handicap accessible bathroom in the space currently designated as the Ladies Room. The revised design includes removal of door and door frame into hall accessing bathrooms and widening that opening, replacement of the existing door with a wider door into the bathroom, removal of stall walls, flooring replacement and paint. Hand hold bars will be attached to the walls near the toilets in both bathrooms. The estimated cost is hundreds of dollars for materials only as Dave stated he will not charge for labor. On motion made by Jim, seconded by Mike, the Council unanimously approved proceeding with the redesigned handicap accessible bathroom project.

Annual Meeting. (1) Three church members will be elected to serve on the Council for two-year terms. Church members interested in running for Council should notify Mike or Jim. (2) Annual Reports to be presented include: Pastor Bridget's; Five-Year Plan and 2023 Accomplishments-Mike; Financial Affairs and 2024 Annual Budget-Jim; Cemetery Committee and Worship Service Reports-Judy. 3) A special meeting of the Council to prepare for the Annual Meeting is scheduled January 28 at 10:40 a.m.

Drone Video of Church. Jim and Mike are continuing efforts to post the video on the church website.

Minutes of January 21, 2024 Council Meeting Continued

Recycling of Plastic Film. David Dennison and a member of the Delano Women's Club met with the Council and others to discuss the possibility of the church assuming responsibility for the NetTrex Plastic Film Recycling project in Delano. The Council unanimously agreed St. Paul's does not have the people power nor the means to assume responsibility for the program. Michael will contact David Dennison to advise him of the Council's decision. Any church members interested in volunteering to assist should contact David Dennison.

There being no further business, the meeting adjourned at 12:35

St. Paul's UCC will continue to study South America at it's February Cultural Responsive Dinner with a celebration of the food, culture, and people of Chile in the Fellowship Hall on February 17, starting at 4:30 pm. This country runs along the border of Argentina and has 3,728 miles of Pacific Ocean coast. Minutes of January 28, 2024 Special Council Meeting St. Paul's United Church of Christ, Delano

A Special Meeting of the Council of St. Paul's United Church of Christ convened on January 28, 2023 at 10:40 a.m. for the primary purposes of preparing the 2024 Annual Budget and planning for Pastoral replacement. Attendees were Council Members Michael Hagerty, James Holm, Judy Crosby and David Rieder, Pastor Bridget Haefner and church member Vicki Hagerty.

<u>Old Business</u>. On Motion made by Judy, seconded by David, Minutes of the January 21, 2024 Council meeting was unanimously approved as written.

<u>2024 Annual Budget</u>. Council members discussed each line item of the draft 2024 Annual Budget presented by Jim. Following review, Jim will edit a few numbers and forward the revised version of the 2024 Annual Budget to Council members for review and possible approval. The draft budget as it currently exists totals \$64,750, slightly less than the 2023 actual expenditures. The Council plans to forward the final 2024 Annual Budget and Annual Reports to congregants a few weeks prior to the Annual Meeting on February 18, 2024.

<u>Pastoral Search</u>. Mike reported he had a lengthy conversation with and received, a volume of materials from Cindy Mueller of United Church of Christ Minnesota. Mike was informed by Ms. Mueller the pastoral replacement process may take several months. An Interim Pastor may be necessary following Pastor Bridget's retirement until a permanent replacement pastor is in service. Following thoughtful discussion, the Council unanimously agreed to establish a Pastoral Search Committee and selected a church member to possibly lead the Committee. Mike will contact the church member to discuss whether that person has an interest and the opportunity to serve as Chairperson of St. Paul's Pastoral Search Committee.

There being no further business to come before the Council, the meeting was unanimously adjourned at 12:50 p.m.
