<u>Members Present</u>: Michael Hagerty, Jim Holm, Dave Rieder, Kevin Handt and soon to be Associate Member, Meg Conrard. Mike opened with a prayer.

<u>2024 Slate</u> Continued positions include: Mike as President, Dave as Vice, Jim as Treasurer. New members are Kevin as Member At Large and Meg Conrard as Secretary. Motion by Jim, seconded by Kevin. Carried.

<u>Past Minutes</u> Council approved the January 21, 2024 Minutes and the January 28, 2024 Special Meeting Minutes. Kevin made motion, Dave seconded. Carried.

**Financial Report** Jim explained a change in the report format. Previously, Quickbooks Desktop was used to format the report, now a Quickbooks Online program will be used saving the church a few hundred dollars in subscription fees. Current Checking Acct. balance: \$15,345.52, up from \$12,792.67 (1/21/24. Green Wealth Investment Acct. \$404,921.08, up from \$399,217.25 (12/31/23).

<u>Cemetery Committee</u> The Council revisited the topic of separating the Cemetery fund from the General Fund. Members felt that the money should stay in the General fund for maximum interest with the provision that a change in the By-Laws might clarify that the money (\$52,335.00) be secured as a perpetuous sum in the event of the dissolution of the church in the future.

**<u>Roof</u>** An insurance payout has been issued to the church for hail damage incurred August 2023. Dave Rieder has been given authorization to purchase the necessary materials to replace the sanctuary roof this Spring. Upon completion, a second check will be issued by the insurance company. Any extra monies will be used for other building improvements.

#### Pastor's Report None.

<u>MN UCC Conference</u> Two delegates are needed to attend the Conference, to be paid for by the Church.

<u>Pastor Search Committee</u> The committee continues to be in communication with Cindy Mueller regarding the three candidates currently being considered for the ½ Pastor position.

<u>Bridget's Retirement Party</u> Mike, Kevin and Meg will set up Fellowship Hall for 3/17/24 celebration. Jim will secure a wireless mic for use. Food will be catered.

<u>By-Laws</u> The By-Laws will be sent to the Congregation for review and any revisions will be implemented after Congregation and Council approval. There are currently 43 members on the church rolls.

<u>**Bathroom**</u> Currently the Ladies Room is  $\frac{3}{4}$  finished with painting and finishing remaining and the Men's room still needs flooring and fixtures. EDC is  $\frac{3}{17}/24$ . Dave Rieder suggested the possibility of renting Fellowship Hall in the event of inclement weather during Rieder concerts as well as the possibility of utilizing the sanctuary and Fellowship Hall for weddings and other outsider use events.

<u>Miscellaneous Business</u> Ad in paper will need to be corrected when a new Pastor is called, Meg Conrard will be brought in as Associate Member 3/17/24.
