But as for you, continue in what you have learn and firmly believe . . .”

-- *II Timothy 3:14a*

As I write this, our congregation is fast coming upon the opportunity to call a settled pastor. So, God willing, this will be the last Pastor's Note from me. I have enjoyed my time with you *so* much and appreciate all your care and support! I encourage you to greet your new pastor with the same warmth and openness.

In II Timothy, Paul wrote a farewell message to his beloved co-worker in Christ. Timothy. I am certainly not facing what Paul was about to face! And there is some debate about whether this letter in its current form was actually written by Paul, I'm going to accept tradition at face value here. I thought what Paul wrote to encourage Timothy (II Timothy 4:2-5) I would also encourage you to do, as co-workers in Christ with your new pastor.

Proclaim the message – You've got Good News to share in a dark time! Don't forget to share it. Not only in how you live as individuals and what you do as community, but in *telling* people the mission St. Paul's is carrying out.

Be persistent – Paul adds, “whether the time is favorable or unfavorable”. It is discouraging to share something exciting and be greeted with indifference or even hostility! Don't let that stop you! Your job is to share, it is up to other people and the Spirit for whether your message is received or not.

Convince, rebuke, encourage – Paul adds, “with utmost patience”. Remember to engage people. Don't just 'preach at them'. Meet them where they are. Be vulnerable yourselves. Listen well as talk.

Fulfill your ministry – You have a “ministry”. You have been called by God since your baptism. Don't feel sheepish. You have a calling! And you will need to work together with your new pastor to fulfill it!

As for me, I will always remember St. Paul's fondly as a wonderful, eager, faithful community. I would love to hear from you how life is going for you. “Keep the faith!”

Minutes of 2024 Annual Meeting

February 16, 2025

Church Council President Michael Hagerty called the meeting to order at 9:51 a.m.

An **Opening Prayer** by Pastor Kent Meyer was followed by a physical count of 18 members present which constituted a quorum.

Minutes from last year's meeting on 2/18/2024 were approved. M- Charlie Leck S- Shala Holm *

Treasurer Jim Holm presented the **Financial Report**. This year's meeting packet included a written recap of our financial report. Jim highlighted the recap. We met our 2024 budget projection within about \$200, in large part because of generous contributions late in the year. We were lucky to have insurance pay for a new roof and to several people who volunteered time and talents to save the church thousands of dollars. Huge "Thanks" were given. Following the advice of our financial advisor at Green Wealth Mgt. we withdrew \$10,000 in profits from the funds. This money will be used in 2025, as we were able to meet our financial commitments at year end without using it. The financial position of the church is strong starting 2025. The 2025 Budget was presented at \$78,610. This amount is about \$13,000 higher than 2024 due to more building maintenance needed and other increases in expenses as noted. Meeting this increase will require larger offerings in 2025, or the use of funds from our investment account. The 2025 Budget was approved. M- Lani BrownW S-Charlie*

Pastor's Report: Interim Pastor Kent Meyer gave a recap of his submitted written report. He clarified how he is reimbursed for mileage charged for extra trips above regular home-to-church requirements. Kent said that he was very pleased to be our interim pastor and has felt welcomed by all here. He had suggestions for when we hire a settled pastor; it's important that a list of home bound people to be visited be available, and that in general we do better at communicating our decisions & procedures to a new pastor.

Cemetery & Worship Committee Reports were presented by Judy Crosby. The cemetery committee did not meet formally in 2024, but Judy mentioned a couple of needed improvements and the hope that the council will revisit a request made at the 2023 meeting about a change to the Church Bylaws concerning the cemetery. The worship committee met regularly in 2024 and has focused a lot on organ & carillon repairs. They get input from Pastor Meyer about special music and services. Judy also included information about how the church calling list operates in communicating with everyone during weather & health emergencies. Cemetery Committee = Laurence Reider, Chuck Reider, Judy Crosby and Pastor Kent Meyer .Worship Committee = Deanna Becker, Gretchen Stewart, Lani Brown-Worley and Judy Crosby.

5 Year Plan Report and **Accomplishments in 2024** were summarized by Mike Hagerty. Highlights of the accomplishments: Total roof replacement and exterior building repairs that were needed while working on the roof were done, with over 400 hours of labor donated by Dave Reider & family, and Hal Becker. Finished the handicap-accessible rest room and hallway renovations. We hired an interim pastor, Kent Meyer. Extremely generous financial donations allowed support for girl's schooling in Liberia to begin, and other missions were supported, including UCC 5 for 5 missions throughout the year. Mike talked about each category of the 5 Year Plan; Community Outreach, Communication, Physical Building (exterior), Indoor Improvements and Special Events. Our active and willing congregation has continued to pursue the goals of each of the categories such as hosting cultural dinners, Lenten suppers & book studies, painting & other maintenance tasks on our building, and working hard to complete the search for our next settled pastor. The council plans to add the category "Feed our Members" that would include things like encouraging use of the new library area. (Continued Page 5)
